



Take the uncertainty out of your surveillance / locate cases and reduce back-compressing wait time. Why not set up an unmanned camera and see what happens at a residence or workplace every second of the day over the course of a week....a month.....or longer before you conduct manned surveillance.

- Don't use those monster-size hunting cameras that do not fit into an urban environment.
- Don't invest a lot of time in a surveillance and then realize that there are several people at a residence who fit the same description.
- Don't put in hours and hours of surveillance of someone who only leaves the house on Tuesdays at 1pm to 5pm each week (gleaned from a time-stamped TL cam).
- Don't assume that a particular investigator puts in the whole time....find out.

Surveillance Detection Craig Gundry, CHS-VI, CPS



Surveillance Detection (SD) is a nonaggressive form of detecting, confirming and identifying a surveillance effort in all forms. SD is a field tradecraft used to collect intelligence, identify hostile elements and adopt protective measures for yourself, your protectee or your facility.

Those who perform surveillance for a living will become better surveillance operatives. Attendees will learn how to detect foot and mobile surveillance, what are the most common errors of both.

Forensic Photography Denice Weigand, CSI

Photography skills can be an integral part of an investigator's job. Therefore, choosing the correct camera such as the type of camera-(hidden, compact, video, underwater, SLR or DSLR), to use is of vital importance. The circumstances and purpose of the photographs (for example-- court presentation) will determine which is the best equipment to use.

Death Row: It can happen to Anyone. **Jeremy Sheets**



Jeremy Sheets's is America's 95th exonerated Death-Row inmate. Convicted in 1997 of the rape and murder of a 17 year old, Jeremy spent five (5) years on death-row until all charges where dismissed in

His alleged accomplice, Adam Barnett, confessed to the crime and implicated Sheets in exchange for a plea deal. Barnett later recanted his confession and committed suicide before Sheets's trail. In 2000, the Nebraska Supreme Court overturned the conviction because it deemed Barnett's confession "highly suspect", "inherently unreliable," and hence inadmissible without the opportunity for Sheets to cross-examine Barnett. After the U.S. Supreme Court declined to hear an appeal of the Nebraska Supreme Court decision overturning his conviction, prosecutors then dropped the charges against him.

Barnett's statement was the key evidence used against Sheets at trial (State v. Sheets, 618 N.W.2nd 117 (Neb. 2000)



understand the evolutionary process of testimonial evidence and the manner in which it becomes fact and ultimately introduced as evidence..






